Report from the Co-Chair of the Search Committee: Rev. Thomas Warren reported that the Search Committee is preparing for the Retreat, which will take place the last week in August. They are in the process of setting the agenda for the retreat. They will be sure to allow time for the candidates to make presentations and also some space for discernment.
